Article 1.1: Definition and Status

These Additional Supplementary Regulations (ASRs) must be read in conjunction with the HERO Standard Regulations (HSRs). The article numbers are those of the HSRs. Competitors must study the HSRs as well as these ASRs.

The 28th Le Jog will be run by HERO-ERA under a Clubman Historic Road Rally Permit (no. TBA) issued by Motorsport UK and a licence (no. TBA) issued by FIVA and is open only to members of the promoting club in compliance with the Regulations of Motorsport UK in compliance with the FIVA International Sport Code; the HSRs; these ASRs; and further Bulletins for the event, which may amend these ASRs and the HSRs.

IMPORTANT NOTE: All motor sport is potentially dangerous. The onus is on competitors to drive carefully and safely at all times. The Organisers accept no responsibility whatsoever for any accident or injury befalling competitors, and do not undertake to provide rescue or assistance of any kind. All competitors will be required to sign the indemnity at Signing On.

These ASR's MUST be read in conjunction with the HERO Standard Regulations which contain all the necessary information. The 2023 version will be found on the Event page from January 2023.

Article 3: Eligible Vehicles

Please note that due to Motorsport UK regulations, in some cases it will be necessary for the Organisers to apply for waivers if your car is registered after 1st January 1968.

In order that the Organisers are able to apply for waivers (if necessary) on your behalf, could you please supply the following information:

- Three photos – one general exterior view, one internal view and one of the engine bay.
- A copy of the vehicle registration document. If your vehicle has been imported it will be necessary for you to provide a copy of documentation that confirms the original build date of the car.

On receipt of the information above, confirmation will be provided as to whether additional photos or other information are required before the waiver application can be processed.

Article 3.2: Classes

Competing vehicles will be divided into five categories. These categories may then be split into classes to provide the best competition between crews and may include criteria for body style, cubic capacity and design age.

The provisional list of category is as follows:

Category A – Cars of a specification valid before 1st January 1942

Category B – Cars of a specification valid between 1st January 1942 and 31st December 1961

Category C – Cars of a specification valid between 1st January 1962 and 31st December 1967

Category D – Cars of a specification valid between 1st January 1968 and 31st December 1974

Category E – Cars of a specification valid between 1st January 1975 and 31st December 1981

Category F – Cars of a specification valid between 1st January 1982 and 31st December 1985

Category G – Cars of a specification valid between 1st January 1986 and 31st December 1990

Categories may be merged if there are insufficient cars entered in any one category or class.

All vehicles must be taxed and insured for the public highway. They must further comply with Motorsport UK Technical Regulations and in particular with J5 and R19.1.

Article 3.5: Required Equipment

All vehicles with the exception of Category A cars must be equipped with **Winter Tyres on all wheels and spare wheels**. This means all tyres must carry the 3 Peaks, Mountain and Snowflake (3PMSF) marking. Failure to present the car at Scrutineering with the tyres as required will result in a refused start. If you wish to have clarification on the tyre proposed, then please email the Technical Team – technical@hero-era.com

Simple Rule; No Winter Tyres = No Start

Article 5.2 – Eligible Competitors – Licences

For UK Residents - As for all events run in the UK by HERO-ERA in 2023 and beyond, all competitors whether you're a driver or a navigator are required to have a Current Motorsport UK Competition licence (or a Competition Licence issued by your country's governing body) if you don't hold such a licence you must apply for an RS Clubman licence. This licence is free of charge and can be obtained by going online to the Motorsport UK site and making a formal application. If you held a 2022 Licence you will need to renew it for 2023.

You will then be issued with a competition licence which will give you your competition licence number. You will also need to bring the competition licence with you for inspection at Signing-On or if you have a temporary number, please bring the email confirmation.

Should you require any assistance regarding this, then please do not hesitate to contact the office who will give you any guidance they can.

For Non-UK Residents – Any Non-UK resident that does not hold a competition licence issued by the motorsport governing body of their native country can apply for a Motorsport UK RS Clubman licence. This exercise must be completed before the event so that competitors can bring the UK licence to the start venue.

This will allow you to proceed, all correspondence will be sent to your email address so that is the critical part of the application to be completed

Article 6.1: Entry Applications

Entries will be accepted on a first come first served basis to those competitors who have completed the entry form in full and paid the deposit. If full payment isn't received by due date listed under Entry Fee & Refunds the place will be offered to the first reserve on the waiting list.

All participants must be a minimum of a HERO-ERA Club member, applications can be made through this link <https://heroevents.eu/hero-membership-2/>

Article 6.2: Maximum and Minimum Number of Entries

The maximum number of entries allowed to take part will be 100, the minimum will be 20.

Article 7.1: Entry Fees

The entry fee as shown on the HERO -ERA website, for a crew of two includes:

- Rally participation

- Map book

- Accommodation in a twin or double room, 2nd & 3rd December inclusive

- Welcome buffet, lunch, evening meals & refreshments at specific locations

- Gala dinner and awards presentation

- Rally plates and side number panels

- Event memorabilia

Article 7.2: Refund of Entry Fees

Cancellation Policy – If cancelled in writing prior to 24th August 2023 (100 days prior) all payments made will be returned less the non-refundable deposit. If cancelled in writing between 25th August 2023 and 13th October 2023 (50 days prior) the full fee will be retained but wherever possible we will allocate part of the entry fee to a future event less the non-refundable deposit. After 13th October 2023 no refunds or transfer will be possible as 98% of the events costs will have been paid or committed at that point.

We advise that you take out your own event cancellation insurance cover.

Article 11.1: Route Description

The total distance of the event will be about 1500 miles, and the event mostly takes place on tarred roads apart from some sections which may be on private land utilising both surfaced and smooth gravel surfaces. On each leg there will be regularity sections and special tests. The special tests will be on private land.

Article 11.2: Road Book and Other Instructions

A detailed map book and other instructions will be provided to enable the competitors to follow the prescribed route and time schedule. All distances will be provided in miles and kilometres to the nearest hundredth.

Article 11.3: Maps

A high quality A3 map at a scale of 1:50,000 will be supplied to crews before the start of each Leg and this map book must be used to plot the route.

Article 25.1: Awards for General Classification

No overall awards will be presented.

Article 26: Insurance

The Organisers have applied for a Blanket Certificate of Insurance to provide competitors who wish to use the scheme with third party cover to meet Road Traffic Act requirements on the road sections of the event.

The premium will be **£200 (subject to confirmation)** for both crew members to cover the event's 'Driver Change' sections. This premium should be paid in cash at Documentation.

All competitors who will be driving on the event will be asked to sign an insurance declaration that they have cover for Road Traffic Act requirements, and to confirm that all drivers, either (a) are covered by an extension to private motor insurance to include cover whilst participating in the event; or (b) are able to comply with the following declaration.

INSURANCE DECLARATION

Vehicles must have Insurance in place which provides, as a minimum, Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or by purchasing additional cover as an adjunct to an existing motor policy.

If a competitor uses an extension to an existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor.

If a competitor wishes to purchase additional cover via the organisers then they can do so prior to the event providing they comply with the following:

Age 19 years or over

Has held a full licence for a minimum of 6 months

Had no more than 6 points on their licence

Has had no more than 1 fault claim in the last 3 years

The vehicle must hold a valid MOT Cert and Road Tax, unless exempt from doing so

Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

Any competitor who falls outside these parameters may be offered cover at equivalent terms or an agreed price, if approval from Reis Motorsport Insurance has been obtained by the event organisers, prior to the event.

Additional cover provided by this scheme is only effective whilst the vehicle is actively competing in the event, and remains under the control or direction of the event organiser(s). Cover will cease immediately if you are precluded, excluded or retire from the event.
